

How to Request Data from Explore Minnesota

Requests must be submitted using the following instructions

Request data from Explore Minnesota by following the guidelines below and formally submitting the request to Chris Morgan <u>and</u> Jake Juliot. Sample requests are on the following pages.

Requests must be directed to the Executive Director:

Make your request under the MN Government Data Practices Act, not the federal FOIA

State that you are requesting information under Minnesota Statutes, Chapter 13.

Ask for access to data rather than asking questions

Under the Data Practices Act, Explore Minnesota is required to respond if you ask to inspect or get copies of government data but is not required to answer questions. Below are examples of what is an acceptable request and what is not.

NOT acceptable

Why did Explore Minnesota promote [XYZ]?

Acceptable

I would like to inspect/request data between [date range], that document [XYZ].

Ask to inspect data before asking for copies

Inspection is free, but you may be charged for copies of government data. If you request copies after inspection, ask for an estimate of the costs.

Ask for a written denial

Ask for the specific statutory basis in writing if the entity redacts or withholds any data. An entity is required to give you this information.

Final notes

By law, Explore Minnesota must comply with data requests in "an appropriate and prompt manner." We will respond to your request within a reasonable amount of time. We cannot require you to identify yourself or ask why you are requesting the information. You may choose to provide contact information so we can respond if your request needs clarification.
